#### PENAL NOTICE

ANY OTHER PERSON WHO KNOWS OF THIS ORDER AND DOES ANYTHING WHICH HELPS OR PERMITS THE DEFENDANTS TO BREACH THE TERMS OF THIS ORDER MAY ALSO BE HELD TO BE IN CONTEMPT OF COURT AND MAY BE IMPRISONED, FINED OR HAVE THEIR ASSETS SEIZED

- 3. The Respondents other than the Fifth Respondent must within 7 days of service of this order on them send the Applicants' Solicitors in writing the names, address (if known) and any other contact details (including social media details) of:
  - a. Any other individuals who are or have been members of any group or groups of climbers and/or parkour practitioners and/or free-runners to which the Respondents (other than the Fifth Respondent) or any of them belong.
  - b. Any other individuals with whom the Respondents (other than the Fifth Respondent) or any of them have climbed buildings and/or entered land, in either case without the owner's consent.
- 4. This Order shall be served as follows:
  - a. The Applicants shall serve a copy of this order on Caudia Ceausu by [DATE] by [METHOD OF SERVICE IF ALTERNATIVE METHOD DIRECTED].
  - b. [Any further service of the Claim Form, Application Notice, evidence in support on the litigation friend]

- c. The Applicants shall serve this order on the First, Second, Third, Fourth, Sixth and Seventh Respondents by sending:
  - i. a scanned copy of the sealed order to each of them by means of the email addresses and/or social media channels listed at page 38 of exhibit JDR1.
  - ii. If it is not possible to send or attach a scanned copy of the order, sending them a link to a webpage or network location where they may access a scanned copy of the sealed order.
- d. Service of this order in accordance with paragraph 4.c. above shall pursuant to CPR 6.27 be deemed good service of the order on the Respondents referred on in paragraph 4.c.
